Membership Categories

Student membership is open to those enrolled in a program of study leading to a degree or certification in the mental health field and who have an interest in trauma and dissociation. Student Membership is also open to trainees and interns in the mental health professions who are practicing under supervision.

Emerging Professional membership is open to mental health professionals who have completed an advanced degree and are in the first three years of their career (or first three years after graduation for researchers).

Professional membership is open to professionals primarily involved in the provision of services, research, education or public policy in an area related to trauma and dissociation. All members must act in accordance with the Code of Conduct. Members who are mental health or health care providers must be either licensed professionals in good standing with their professional board or mental health professionals who are practicing under the supervision of a licensed professional or qualified with the accepted legal or cultural standards for conducting clinical practice in their locale.

Retired Membership is open to Members who have retired from active practice or research and are working less than 10 hours spent in clinical work, consultation or teaching. To be eligible for Retired Membership, the Member must be at least 65 years of age and have paid dues to the Society for 10 or more years.
